

Automated courtesy reminder calls are made one to two days after your regular bill is due and an automated disconnect call will also be made two days before water is disconnected. These changes were implemented in 2009 to help keep costs down, while still giving customer's extra notification on the status of their account. Unfortunately, it is not possible for the members to choose to receive only one call. If you would like all the reminder calls, please make sure the Association has your current telephone number. *Thank you*.
